Q: If you could tell patients to stop doing one thing, what would it be?

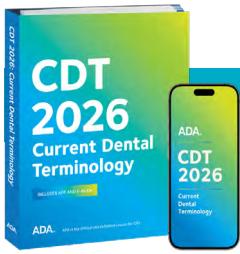
A: One of the things that I'm big on is sugar nutrition counseling. I think if we get the nutrition right, we help patients come in here who maybe have a lot of dental problems get their work done and then the work lasts if they're monitoring their sugar intake.

Q: What is the best dental advice you've ever received?

A: No one cares how much you know until they know how much you care. If your patients know that you care about them, they're going to listen to you. You can be the smartest guy in the world, but if you don't care about the patient, they can smell it a mile away. If you're not honest with them, they're going to know it, but when they know you care about them, they open right up to you and they're willing to work with you and form that relationship.

Q: What is the best thing about being a Delta Dental dentist?

A: I think it's the patients. That's really why we're in this business—we enjoy working with patients and helping them navigate their dental care. 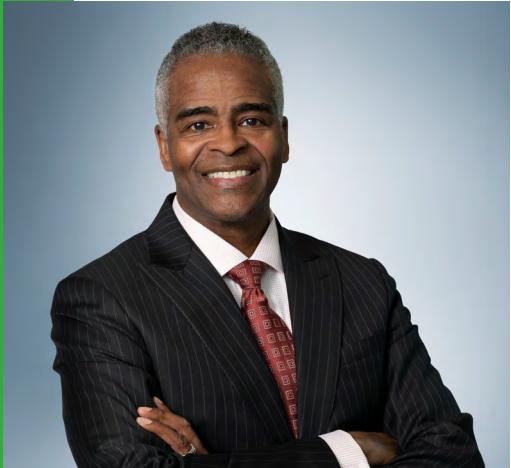


2026 CDT Code Changes

The American Dental Association's CDT procedure codes and nomenclature have been updated for 2026. The CDT updates include 31 new codes, 14 revisions, 6 deleted codes and 9 editorial changes.

Accurate coding promotes faster claim processing and fewer errors, so Delta Dental recommends that each dental office has a current copy of the CDT. With all the code changes, dental offices are encouraged to verify the services covered for patients before providing treatment.

STOP! DON'T SUBMIT THAT CLAIM YET...

We want to make sure your claims are processed quickly and accurately. These reminders and updates will help you brush up on common mistakes and put a crown on your submissions for smooth, successful processing.

Attach Files: Use the attachment feature in DOT for X-rays, remarks or notes.

File Timely Claims: Submit claims within a week of service for timely processing; use the Dental Office Toolkit (DOT) for real-time submission.

Report Every Procedure: Make sure to include all procedure codes for every service provided. Omitting codes may violate fraud, waste and abuse policies.

Submit by Date: Submit all procedure codes for treatments that happen on the same day in one claim, unless there are different providers involved. If the treatments occur on different days, make sure to submit these on separate claims, even if it's the same provider.



GET PAID FASTER WITH DIRECT DEPOSIT

Skip the wait and get your payments straight to your account. Sign up for direct deposit in the [Dental Office Toolkit \(DOT\)](#) for quick, hassle-free payments as soon as claims are processed.

AVOID SURPRISES: CREDENTIALING REMINDERS FOR YOUR PRACTICE

Staying current with your recredentialing helps keep your practice running smoothly, especially since **office or provider updates may take up to 30 days after all required documents are received.** Up-to-date credentials make claim processing faster and more accurate, support timely payments and ensure patients can rely on accurate provider information.
